

Accordingly, Magistrate Judge Deavers is hereby reappointed as a full-time United States

Magistrate Judge at the salary fixed by the Judicial Conference of the United States with her

official duty station being designated in Columbus, Ohio.

Said United States Magistrate Judge shall enter upon the performance of her duties at 12:01a.m. on March 15, 2018, but prior to the commencement of such duties, she shall take the oath of affirmation prescribed by 28 U.S.C. § 453 and § 631(b).

Elizabeth A. Preston Deavers, United States Magistrate Judge is to hold and discharge the duties of her office for a term of eight (8) years from the date of her appointment subject to the provision of 28 U.S.C.A. § 631(c), unless sooner removed.

The Clerk of this Court is directed to file certified copies of this Order in the records of each division of this Court and shall likewise forward a certified copy of this Order to the Director of the Administrative Office of the United States Courts.
