Expert Reimbursement Limitations

CJA 21 COMPENSATION for EXPERT & OTHER SERVICES

(Non-Capital Cases)

If services were completed before January 1, 2024, the maximum **with** prior court authorization is \$2,800; **without** prior authorization is \$900.

\$1,000 without prior authorization See CJA Guidelines at § 310.20.10

<u>Without prior authorization</u>, the maximum applies to the **aggregate** compensation, excluding expenses, claimed by all service providers combined, not to each service provider individually.

\$3,000 with prior authorization
See CJA Guidelines at § 310.20.20
With prior authorization, the maximum applies separately
for each service provider.

CJA 31 COMPENSATION for EXPERT SERVICES

(Capital Cases)

\$7,500 with prior authorization

(Applies to the total compensation payments for investigative, expert, and other services in a case, not to each service individually)
