COMPLIANCE WITH S. D. OHIO :
CIV. R. 5.1(c) :

S. D. Ohio Civ. R. Rule 5.1 (c) provides in part,

“Except as provided herein or unless otherwise authorized by a Judge, all documents shall be filed electronically as a text searchable PDF using the ECF system except that documents filed by *pro se* litigants may be filed on paper.”

A persistent issue exists with documents that are not text searchable being filed in CM/ECF. To address this problem, it is hereby ORDERED as follows:

1. When the Clerk’s Office conducts the quality control of an attorney-filed entry, the Clerk shall examine the document to determine whether it is text searchable. If the document is found not in compliance with S. D. Ohio Civ. R. Rule 5.1 (c), the Clerk shall file a notice of non-compliance. (Attached hereto and made a part hereof as Exhibit A.) The notice will instruct the attorney to refile the document as a text searchable document within 24-hours or the document will be stricken by the Court for non-compliance and/or other actions taken as deemed appropriate by a judge.


2. After the 24-hours has expired, if the document has not been refiled, the Clerk shall notify the presiding and referral judges by email of the non-compliance, including the case number, the docket number of the document that is not compliant, the docket number of the clerk’s notice, and the deadline by which the attorney was to refile the document.

3. The judge shall review the document for non-compliance and issue a final order of non-compliance (attached hereto and made a part hereof as Exhibit B), setting a 24-hour deadline to refile the document as a text searchable document or risk the document being stricken without the ability to refile the document in the future and/or other actions deemed appropriate by the judge.

4. Pro se litigants may still file on paper (except for those in correctional facilities to which the Court has furnished a scanner for electronic filing). When *pro se* filings are typewritten, the Court has the capacity to make them text searchable and therefore more useful to Court users.

IT IS SO ORDERED.
